Hartstein Names Billy Graham As New Yeshiva President; Dr. Miller Cites Appointment As Change For The Better

By Motzei ShemRaw In an effort to revitalize the religious atmosphere of the school, Evangelist Billy Graham has been named the new President of Yeshiva University.

The move followed the sudden decision of Dr. Samuel Belkin to retire because of illness. As Dr. Belkin so eloquently put it in his farewell address, "I'm sick of this school."


The appointment was originally publicized in last Monday's New York Times, though it is expected that confirmation of the appointment will be made to the faculty and student body within three months.

Rumors of Dr. Belkin's resignation had been sufficiently squelched two weeks ago when Yeshiva propagandist Sam Hartstein had produced a picture of Dr. Belkin swimming the Harlem River. So the latest announcement came as quite a surprise to most observers, except to Mr. Hartstein who had made the decision to replace Dr. Belkin three weeks ago. Graham's sudden appointment dld not surprise Ezra Hick, president of GOY who claimed. "I knew something like this was coming for several months. First, girls in the dormitories, now this. The next thing you know, David Berger will be a rosh yeshivah."

Rabbi Jordan Miller, university trouble shooter, tried to allay student fears that the appointment would signify a new religious direction, "As far as I'm concerned Dr. Graham's appointment is only a ploy for Albany. If anything, the appointment of a noted clergyman should only add to the religious atmosphere of the school."

In a press conference following the speech Rabbi Miller was asked why a choice could not have been made within the Jewish community. Miller responded that Graham met certain qualifications that other individuals at Yeshiva did not, specifically a strong theological background. But most importantly, he was the only candidate who did not repudiate the doctrine of *Torah Umadah*. (Dr. Graham does not know Hebrew.)

The general conjecture on campus was that a primary motivation for Graham's appoint-

ment was his close friendship with President Nixon, thus offsetting the bad impression created by Dr. Dunner's acquaintance with the President.

The selection followed a closely contested battle. The Public Relations: Office had at first pushed the candidacy of Norman Vincent Peale (*The Power* of *Positive Thinking*), but it was felt that Graham followed a more fundamentalist position, more befitting an Orthodox institution.

James Pike's name was dismissed because it was felt that he hada't been dead long enough to quality for the Yeshiva Presidency.

Bishop Fulton Sheen had also been scrutinized, but following his sharp attack on the War in Vietnam he was quickly eliminated, for as a member of the Board of Directors said, "Is past nitch for an administrator in an Orthodox institution to be associated with liberal and humanitarian causes." Furthermore, it was felt that one more Sheenie in the administration would not look good in Albany.

Faculty reaction was mixed. Rav Pureness said, "This is the frighteningly logical progression of the attitudes expressed in THE COMMENTATOR these last years."

Dr. Irving Greenberg was more guarded in his response, "I've always welcomed pluralism but Graham will prot bly just continue a tradition of fundamentalist insensitivity."

So far, attempts to ascertain Rav Soloveitchik's opinion have failed, though students perusing the walls have discovered eighteen different views attributed to him. Oddly enough, each view reflected precisely the thought of the student who claimed to have received a definite decision from the Rav. Tauber Defends High Fist Garbage; Jury Convicts As Belkin Is Ousted

The four month-old trial of Rabbi Joshua High Fist for operating a slum tenement in Washington Heights reached a climax today as Mrs. High Fist

at first denied knowing the defendant: Pressed by the defense counsel, Mr. Blazer was forced to admit that Rabbi High Fist indeed was not responsible for the dorm conditions — in fact,

stand in his own defense. Slowly, almost inaudibly, Rabbi High Fist recounted the early days of his life, telling how, as the tallest boy on his block, he was considered the outsider by his peers. He recounted the sorrowful tale of his friends' taunts, as illustrated by the time they stuck a piece of bubble gum on his head in an effort to retrieve a pennsy-pinky from a sewer.

Stung by this abuse, Rabbi High Fist began to search for a means of offering his unique talents to the community at large, and to Jewish youth in particular. Studying the field, Rabbi High Fist decided that housing was his true calling.

He denied any wrongdoing, and stressed his altruistic motives in offering the students "the best accommodations possible." "After all," Rabbi High Fist explained, "I live in the same building. Do I look like a person who would live in a slum?" The question was stricken from the record, on the motion of the defense counsel. Defense Attorney Abraham Tauber, in a brilliant eighty-six hour summation, reminded the court of Rabbi High Fist's true concern for his charges. First, Mr. Tauber cleverly cited the case of Alcott-v. Anderson, which ruled in 1909 that lack of steam, lack of proper garbage removal and paper-thin walls could not legally constitute a slum tenement. A condemned building, yes. A slum tenement, no.

Restaurant Price War Erupts Into Violence; Hostilities Precipitated By Faulty Hot Dog



Zealots Hold Meeting; **Human Values Extolled**

A rabbi representing the Neturai Karta community, delivered a Shiur Klallah last Wednesday night on the important Mitzvah of Sinat Chinam (causeless hate). Invitations were hard to come by as they were only sent to thirty-six select individuals.

The rabbi noted that greater religious enthusiasm could be induced by reactivation of noble concepts such as Sinat Chinam. He elucidated further examples of new Mitzvot for our time, and declared, "Whoever stones a car riding on Shabbat. it's as if he observed all the laws of the Torah.' In the realm of the Aggadic he noted, "Whoever has not publicly defamed a leader of Mizrachi has never experienced pure joy." He also informed the audience that a twenty one year old custom has now been formalized, and that in the future anyone not fasting on Yom Ha'atzmaut would be liable to lashes.

"Skilah Srefah Hereg V'chenek."



High Fist Condemned As Slum Landlord; Attorney Tauber Blabbers For Garbage

(Continued from page 1, col. 3) at certain specified hours -2-3 a.m. and 1:55-2:05 p.m. However, had the student but heeded the list of suggestions offered, such as stuffing old rags and news-paper under the door and around the windows, the heat offered would have easily sufficed.

As for the speedy removal of

garbage from the rooms, Mr. Tauber offered an explanation. Garbage removal at Yeshiva poses definite danger of fire. In essence, he claimed, keeping one's garbage is only in keeping with Fire Department regulations prohibiting the use of canvas bags for garbage collection. Thus, no garbage, no bags. And, most important, no bags, no fire. "If the students can't learn that keeping the garbage in their own rooms is for their own health and well-being, I give up." With those stirring words, the four-month old trial went to the jury.

Hopes for a quick verdict vanished as the jury deliberated the case for two days and nights. Meanwhile, the uptown campus did not remain idle. Richard Sternberg, president of the Yeshiva College Student Council, announced the establishment of a new commission to investigate all aspects of the case, and its repercussions for the Yeshiva College undergraduates. The commission, was composed of the presidents of all the undergraduate councils of Yeshiva, plus the five borough presidents, Mayor Lindsay, Mario Proc-cacino and Gil Hodges. "This commission will really get to the heart of the matter," was President Sternberg's reply to a battery of newsmen.

Finally, the jury announced that it had reached a verdict at 3:00 p.m. The announcement was held up momentarily, as Rabbi High Fist was forced to cut his lunch short. In a hushed courtroom, the verdict was read. "Guilty as charged." Defense Council Tauber rose to his feet. "This is insanity." No one in the court was sure whether Mr. Tauber was referring to the verdict — or to his grounds for appeal.


